1. ARTICLE 9 SECTION 1 PRIMARIES. THE COMMITTEE SHALL NOT
PARTICIPATE NOR GIVE THE IMPRESSION OF PARTICIPATING IN PRIMARY
ELECTIONS, WHETHER THEY BE PARTISAN OR NON-PARTISAN,

AND JASON BUCKEL WAS THE ANNOUNCED V-P OF THE EHRlich CAMPAIGN
AND JEFF BAILEY WAS WEARING EHRlich T-SHIRTS AT THE CENTRAL
COMMITTEE MEETING PRIOR TO THE September 14 2010 PRIMARY

2. ARTICLE 3 SECTION 5

JEFF BAILEY WAS ABSENT FOR MORE THAN 3 MONTHS FROM THE MEETINGS
AND WAS ALLOWED TO RETURN.
